## 2024 SWIMMING POOL RULES AND REGULATIONS

# Canterbury Woods Homeowners' Association

Opening Day: Saturday of Memorial Day Weekend

Closing Day: Monday Labor Day

#### POOL HOURS: Daily 12:00 PM - 8:00 PM

Limited hours during the remaining school year dependent on staff availability. Pool will be closed on days forecast below 70°F or for bad weather at our discretion.

#### **SAFETY**

- 1. Pool facility must be staffed with 2 lifeguards at all times. If necessary, current board members may step in to become gate keeper in place of 2<sup>nd</sup> guard.
- 2. Use of the pool facilities are prohibited unless lifeguard is on duty.
- 3. The following safety precautions will be observed at all times:
  - a. No running within the pool area
  - b. No pushing, dunking or jumping on people.
  - c. Diving is permitted only in the deep end of the pool.
  - d. Swimmers must be aware of divers and stay clear.
- 4. Children under 10 years of age will not be permitted inside the pool enclosure unless accompanied by an adult, family member or babysitter over the age of 14.
- 5. Children under the age of 5 years old will not be permitted in the main pool unless supervised by an adult, family member or babysitter over the age of 18 years old.
- 6. Lifeguard(s), at any time, may call upon a swimmer to prove his/her ability to swim. If the person cannot prove this ability to swim, he/she will be restricted from using the deep end of the pool.
- 7. The pool and/or the entire premises may be closed when deemed necessary by the pool manager(s) or lifeguard(s) for inclement weather conditions, safety or staffing issues.
- 8. In the event of thunder/lightning, pool will be closed with no swimming for 30 minutes.
- 9. Break periods will be at the discretion of the pool manager(s) to rest children as a safety factor and to offer the opportunity for adults 18 years and older to swim. The length of the break will be 15 minutes and typically will be called every hour. This will be enforced throughout the pool season.
- 10. Clothing or attire that hinders swimmer's ability to swim is prohibited at all times from the main swimming pool. Clothing that may easily come off or fall off is prohibited from the main pool. If a swimmer is not wearing a bathing suit, the attire **MUST BE swimsuit material.**

#### **ELIGIBLE USERS**

- 1. The pool facilities may be used ONLY by members in good standing with the Canterbury Woods Homeowner's Association (CWHA), and members of their immediate family, subject to the provisions of the rules and regulations.
- 2. A member in good standing is defined as a member of CWHA who has paid current annual dues.
- 3. The immediate family of a member is defined as all persons permanently residing in the member household.
- 4. A guest is defined as any person not in the immediate family of a member.
- 5. POOL TAGS MUST BE PRESENTED AND WORN AT ALL TIMES. WE WILL NOT TOLERATE THE EXCHANGE OF POOL TAGS THROUGH THE FENCE OR ANY OTHER WAY. OUR LIFEGUARDS ARE AUTHORIZED TO EJECT ANY SWIMER OR CWHA MEMBER.

#### **GUEST PRIVILEGES AND FEES:**

- 1. No guest will be permitted to use the pool facilities if he/she is the guest of a delinquent dues paying CWHA member.
- 2. All guests must obtain a guest pass from the lifeguard(s) on duty upon entering the pool facilities.
- 3. All guests using pool facilities must be accompanied by a member or one of the member's immediate family that is living in the household over the age of 14. Limit of 2 guests for residents under the age of 18.
- 4. Members are responsible for their guests at all times and will be held liable for damages to property of CWHA caused by their guests.
- 5. Guest passes may be purchased for cash only by adult members at the rate of **\$4.00** per person for anyone 3 years of age or older. Lifeguards are not expected to have change or break large bills.
- 6. Maximum of 8 guests per household.
- 7. All residents and guests must sign in and have pool tags checked upon entering the pool area.

#### **GENERAL**

- 1. Residents can bring their own beverages. No glass containers. NO EXCEPTIONS
- 2. Chewing gum or animals are NOT permitted inside pool premises.
- 3. All waste and refuse material must be disposed of in the containers provided.
- 4. No floating objects or foreign matter of any type including rafts, fins and inflatable rings. Sponge nerf balls may be used in the main pool, as long as ball playing is under control. Water wings are permitted, but only if a parent or responsible adult is with the swimmer in the pool. Noodles are allowed (if not connected to one another) in the main pool only.
- 5. Smoking is strictly prohibited on the pool premises. If found smoking on premises, lifeguard(s) have authority to ask the violator to leave the pool premises immediately. If the lifeguard(s) deem a resident a repeat offender of this rule, the Board of Trustees may revoke the homeowners pool tags for the year.
- 6. THE POOL MANAGER(S), LIFEGUARDS AND/OR OTHER PERSONS DESIGNATED BY THE BOARD OF TRUSTEES HAVE BEEN CHARGED WITH THE RESPONSIBILITY OF OPERATING THE POOL FACILITIES AND ENFORCING THE RULES AND REGULATIONS PERTAINING TO THE USE THEREOF IN A MANNER WHICH WILL BE TO THE BEST INTEREST OF THE CANTERBURY WOODS COMMUNITY. COOPERATION, RESPECT OF THEIR POSITION AND COMPLIANCE WITH THESE RULES AND REGULATIONS WILL ASSURE EACH OF US A SATISFACTORY USE OF THE CWHA FACILIEIES. REPEATED VIOLATIONS OF ANY RULES WILL RESULT IN RESTRICTION OF INDIVIDUAL PRIVILEGES AND/OR DENIAL OF THE USE OF THE POOL FACILITIES.
- 7. While every precaution will be exercised for the safety of the people using the pool, the CWHA, its trustees and/or employees assume no responsibility in the case of accident, injury, death or loss of personal property.
- 8. The CWHA reserves the right to change, alter, revise and amend these rules and regulations at any time in the interest of the safety, health and well-being of the members and their guests.
- 9. Clothes, towels, pool toys, etc. left at the pool for more than 1 week will be collected and disposed.

### POOL RENTAL (to be determined based on lifeguard availability)

- 1. A CWHA Homeowner in good standing may reserve the pool area from the Pool Manager.
- 2. Rental hours are **8:00 PM 10:00 PM** when the pool is available and operational.
- 3. The CWHA homeowner reserving the pool **MUST BE PRESENT** during the pool party and assumes all responsibility for damage and cleanliness, as well as behavior of all guests.
- 4. A deposit of **\$50.00** is required. The deposit is refundable if all usage conditions are met and damage to the facility does not occur. Pool and Park **MUST BE LEFT** in clean condition.
- 5. Two (2) CWHA lifeguards must be hired when renting the pool. Lifeguard wages are \$20.00/hr. per lifeguard, paid by renter directly to the lifeguards at the end of the rental period. Pool manager reserves the right to add additional lifeguards at a rate of \$20/hr. based on party size.
- 6. Pool parties must be reserved at least one week prior to party date. Last minute parties are not permitted.
